### **Annual administration fee for taxi and luxury hire car licences**

A reminder to all operators that the fee – payable for each licence – is due on 1 April 2012, as advised in Newsletter 62 of January 2012.

#### **Taxi licences:**

Fees for licences operating in respective taxi areas for 2012-13 are:

Hobart and Launceston - \$613.20

Devonport/Ulverstone/Burnie/West Tamar/Perth/George Town/New Norfolk - \$462.00

All other areas - \$254.80

#### **Luxury Hire Car licences**

The annual administration fee for Luxury Hire Car licences for 2012-13 is \$358.40.

Notices concerning the fees for all licences were posted to licence owners in early February. As with previous years, the fee for each licence is due on 1 April 2012.

All operators are reminded that if a fee is not paid by 1 April, the licence lapses. A taxi or luxury hire car service cannot be provided under a lapsed licence. Where the fee is unpaid after 28 days the licence number-plate is void and will be cancelled, and can be seized by a Transport Inspector. Payment of a late fee will re-instate the ability to provide a taxi or luxury hire car service.

## **New Personal Property Security Register**

The Australian Government has recently established the Personal Property Security (PPS) Register. This is a register where details of security interests in personal property can be registered and searched and supercedes (among other things) each State and Territory Register of Encumbered Vehicles and Bills of Sale Register.

Personal property is defined as any form of property other than land, buildings or fixtures that form part of it or a right (such as water rights), entitlement or authority. To be considered personal property, one person must be able to transfer the ownership of the property to another person.

Some common examples of personal property are boats, caravans and cars. Personal property also includes non-material items such as taxi licences.

The PPS Register is relevant for organisations or people who finance the purchase of taxi licences, as security interests in taxi licences will be registered here.

### **What does this mean if I am buying a taxi licence?**

If you are considering purchasing an existing taxi licence, you are advised to search the PPS Register to find out whether a security interest is registered against the licence before you buy the licence. This will allow you to see whether a finance company or bank has an interest in the licence.

or phone 1300 007 777. A small fee will be charged for this search.

DIER does not require buyers of taxi licences to search the PPS Register before buying a licence, but strongly recommends that you do so for your own protection. If you have not searched the Register, you will have no protection if a financier with a registered interest in the licence wishes to claim against it.

### **What does this mean if I am providing finance for a taxi licence?**

If you have a security interest against personal property, such as a taxi licence, you should register your security interest in order to protect it.

The Commonwealth Personal Property Securities Act 2009 is intended to protect buyers of personal property where they are not aware of an existing security interest (that is, where the buyer has searched the PPS Register, but the interest is not registered on it). If this happens, the sale of the property effectively voids the unregistered security interest and the person with the interest no longer has any claim to the property.

The PPS Register does not affect any legal requirements DIER has in place for the ownership of taxi licences. All licence transfer processes remain the same. For example, if a finance company repossessed an owner-operator taxi licence, the licence could still only be transferred to a person who meets the requirements to hold one of these licences.

We write to share with you details of events, which involve road closures and increased visitation to your local area.

#### **Friday 30 March, 6pm-11pm: Kelly's Steps Second Landing Party**

Free concert held on Kelly's Steps, Kelly's Lane Salamanca. Bands ranging from bluegrass to rock will play short sets on the landing above Kelly's Steps with audiences watching from the laneway and Kelly's Garden (Salamanca Art Centre outdoor venue).

Public can enter and exit via Kelly St and Salamanca Place. **Road closure at the end of Kellys Street to McGregor St, 5pm-11.30pm. Accessible for local resident traffic. Expected attendance 1000 (throughout the course of the night).**

#### **Saturday 31 March, 1pm – 1.05pm: Davey Street**

A short traffic delay will occur **on Davey St between Murray St and Salamanca Place at 1pm – 1.05pm**. The traffic delay will not affect Metro bus services, but taxis and hotel bus services should be aware and may seek alternative route.

#### **Sunday 1 April, 2pm – 2.40pm: The Pageant**

A family-friendly pageant starring a community cast and school children will tell stories from the history of SAC. Located on Salamanca Place in front of the SAC building with a stage located on the footpath and audience on the street and Salamanca Lawns. As part of the set a giant piñata in the shape of an industrial lift, will be suspended by a crane located with the road closure area.

**Road closure Salamanca Pl, Woobys Lane to Kelly's Steps, 8am – 5pm. Expected attendance approx 1000.**

### **Transport Access Scheme – Interstate taxi vouchers**

Members of taxi concession schemes operating in other Australian States and Territories who visit Tasmania can arrange to be issued with Interstate Taxi Fare Concession vouchers before they leave home. These vouchers can be used by the scheme member to receive the same taxi fare concession they would receive in their home State or Territory, and should be accepted by Tasmanian taxi drivers.

Interstate taxi fare concession vouchers collected from interstate visitors can be redeemed from the Transport Access Scheme in exactly the same way as Tasmanian taxi vouchers are, and the same level of trip information is required to be completed.

### **Statutory Declarations – lost, stolen or damaged licence number-plates**

From time to time, operators need to contact DIER to obtain a replacement licence number-plate.

DIER requires wherever possible a damaged plate to be returned to DIER. Where a damaged or lost plate cannot be physically returned to DIER, a Statutory Declaration must be completed by either the person leasing the licence, or the licence owner.

The Declaration must describe the circumstances and date of the loss, theft or damage. For taxi licences, the Declaration must be completed by either the person leasing the licence, or the licence owner.

For luxury hire car licences, the licence owner must complete the Declaration.

Declarations completed by persons other than these will not be accepted. Remember to have the Declarations appropriately signed by a Commissioner for Declarations or a Justice of the Peace, dated and witnessed. Service Tasmania staff are Commissioners for Declarations.
